


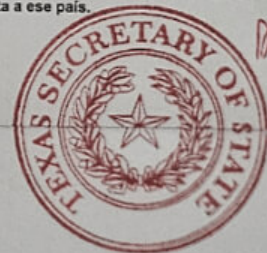

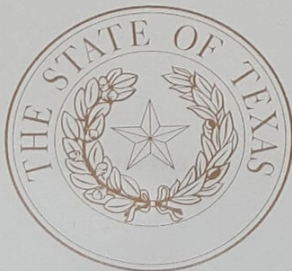

Pre-10/1/23 Texas Authentication Certificate

A USA apostille certificate or USA authentication certificate will be issued by one of the fifty U.S states or by the U.S Department of State and it will be an 8 1/2 x 11 sheet of

paper that will be attached to your document either by a staple or a grommet. Some states like Texas as of 10/1/23 will have a type of stamp/seal placed on it and other states don't use stamps like Texas didn't pre-October 1st, 2023.

Your apostille certificate or authentication certificate is printed onto regular printer paper on the letterhead of whatever state's secretary of state office issues it.
